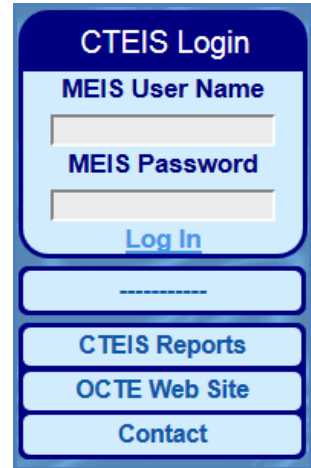

REVIEW AND SUBMISSION OF THE FOLLOW-UP REPORT FOR FISCAL AGENCY AUTHORIZED OFFICIALS

In the web-based Career and Technical Education Information System (CTEIS), reports may only be submitted by an authorized official of the Fiscal Agency. CTEIS will inform Fiscal Agency authorized officials via email when reports at the building-level are ready for review. Likewise, CEPD administrators are notified by email when a report is submitted by a Fiscal Agency authorized official.

CEPD Administrators must examine all reports submitted by Fiscal Agency authorized officials and indicate that the CEPD Administrator review is complete so that the reports may be accepted and compiled by the Office of Career and Technical Education.

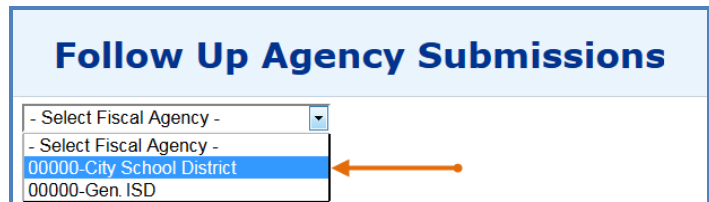
This booklet contains instructions for the review and submission of Follow-Up reports for Fiscal Agency authorized officials.



To begin reviewing your report:

Navigate to www.cteis.com and enter your MEIS user name and password into the panel at the top left side of the screen to login to CTEIS.

Observe the menu buttons within the left-hand navigation panel of the login screen. Select **Fiscal Agent → Follow-Up Submission** to go to the Follow Up Agency Submissions screen. If



necessary, choose a Fiscal Agency from the drop-down menu; the "Follow Up Buildings Completion" grid will display a list of operating buildings within the selected Fiscal Agency and the report status of each building.

Viewing your reports:

You will need to review the reports of each building within your "Follow Up Buildings Completion" grid. These reports become available only when building reporters submit data for the current year. To review the Follow-Up report for a building, click the **Report** link to the left of the building name.

To print your lists and reports, you must first export them to another format. Using the "Export to the selected format" drop-down list, choose either Acrobat PDF, Microsoft Excel, or Rich Text. The "Export" button becomes active when your selection is made, and you may save and print hard copies of your reports from within the chosen application. PDF is the recommended printing format as Excel and text exports may not correctly render the layout of your report.

Submitting your reports:

On the Follow Up Agency Submissions screen, an “X” appearing under the **Bldg** column indicates a building that has submitted report data for review. During the course of your review, if any report requires revision, you may click the Comp./Ret. link and use the **Return** button to request that a building's enrollment information be edited and resubmitted.

When you are satisfied that a building report is complete and accurate, indicate your approval by clicking the Comp./Ret. link and using the **Complete** button within the resulting pop-up window. An “X” appears under the **FA** column to indicate that the report can now be reviewed and approved by your CEPD Administrator.
