Fall CTEIS: What you need to know!

New Programs

If you are considering starting a New Program this year, the submission dates are: Sept 1 – Nov 15, 2017 and Dec 1 – Feb 15, 2018. LCTS programs' applications are due on October 5th, 2017. The process has changed slightly this year — you can find the updated information and all that you need to know in the [New Program Application Guides](#).

Dual Enrollment & the Teacher Student Data Link (TSDL) Reporting Requirements

TSDL reporting requirements require that all courses that are considered "Dual Enrollment" must report their course type and what College and High School credits are available. This information must be reported on the Manage Courses form available in CTEIS. For more information, download the [Fall Data Entry documentation](#).

Expenditures

There are no significant changes in the Expenditures data entry process this year. Please note, however, that the training webinars will be in September instead of October this year to allow more time to prepare the Expenditures reports.

Certification Reporting

Beginning this year, districts will be asked to report what certifications are offered with each State-approved CTE program. The due dates for this information have been moved to correspond with the EOY completion, occurring in late June. The available list of industry recognized credentials is currently being developed and should be completed shortly. Assessment Data Collection & Coordination

Quarterly Data Uploads

For the 2017-18 school year, PTD Technology will no longer extract student assessment data from CTEIS for students eligible to take the NOCTI assessments. However, there is a template being created that will allow programs to export data from CTEIS and import data into NOCTI's system. PTD technology is working on this template and when it is finalized, the template and instructions will be disseminated to the field on how to export data from CTEIS and import into NOCTI's system. Please note that if data is not exported from CTEIS and imported into NOCTI's systems then programs must ensure that accurate Student UICs are entered; otherwise, the OCTE will not be able to match student assessment data to the CTEIS system.

Precision Exams

PTD Technology will continue to extract student assessment data from CTEIS for students eligible to take the Health assessment. Students must be *enrolled in CTEIS course-sections by the following dates:*

November 24, 2017

January 12, 2018

March 23, 2018

April 13, 2018
