Notes from Conference Call

1. Roll Call of CEPDs. (See attached)

2. PTD Update

- The file import process has been re-engineered and simplified. The number of required fields has been reduced – demographic fields now imported from the Michigan Student Data System (MSDS) have been eliminated from the CTEIS import process. The import specs were sent out in early summer, and are available on both the CTEIS (www.cteis.com) and PTD Technology (www.ptdtechnology.com) websites: ***Excel Import File Specifications***. An email notice regarding this change will be sent to the CTEIS listserv today.
- Beginning this school year (2009-10), the **4483A** Report will no longer be submitted. However, districts are **STRONGLY** encouraged to enter their course sections, student enrollments; and to update their data throughout the year as changes occur and time permits. CTEIS Reporters will have the ability to run validation reports to check for UIC errors, etc., and are strongly encouraged to do so. The Level 5 and CEPD Administrators will have the ability to review the validation report, but will not be able to submit their approval until the final validation is run (spring of 2010). **Please do NOT wait until the last minute to begin entering data.**
- The 4483D Report will be open in CTEIS for data entry until the 4483D Report is due this spring (April 30, 2010).
- CEPI has changed the UIC Checker utility. Although it is faster and more efficient, the error messages generated provide less information regarding the problem.
- With the elimination of the 4483A Report, there will be no in-class trainings this fall. However, PTD Technology is developing a video training that will be available, and will host at least one webex refresher training session. (An announcement regarding these trainings will be sent out in the near future.)
- 4033 Expenditure Report – PTD is currently reviewing the data and making tweaks to the system. The 4033 will be released by end of the week. Training for the 4033 will start in October. A video is being developed and webex sessions will be offered.
- 4301 Unduplicated Enrollment Report – is currently being revised to accommodate changes in the data collected, and will be released shortly.
- Carrie Drake has left PTD Technology, and will be missed. Marie Beauregard will be the new head trainer. Her contact information will be sent out via the listserv.

3. OCTE Updates

- A letter was sent to all Level 5 Authorized Officials regarding the ***Exit Status*** in MSDS. Although the Exit Status is imported from MSDS, the fall 2009 MSDS data submission is not

available to CTEIS for import until January. Exit Status is part of the Core Performance Indicator (CPI) data that OCTE is required to submit to the federal government by December. Therefore, if the Exit Status for any student changed after the 2009 MSDS EOY data submission SENDING DISTRICTS should be sure that exit status is updated in MSDS by October 14. This is just a reminder for sending districts and an explanation of the importance for Perkins reporting.

- The Data Code Manual is now available in CTEIS. Instructions for using the Data Code Manual can be found on the CTEIS website (www.cteis.com) as well as the PTD Technology website (ptdtechnology.com) under **Data Code Manual** – **Using the Online Data Code Manual**.

4. Issues from CTEIS Users

- CTEIS Users would like the ***Copy Section*** function expanded to include teachers, sub-sections, and segment information. Doug will check into it.
- Joel had a question about ***Early Rosters***, so Jill contacted CEPI for clarification. District exit status is to be updated in the Maintenance collection (deadline October 14th). This information cannot be collected as part of the Early Roster collection which usually closes before the school begins and final exit status is known.
- CTEIS Users would like the ability to run summary counts. PTD is working on adding this function to the Ad Hoc Query Tool.
- CTEIS Users would like ***Sending District*** included on the 4301 Error Report – Doug will look into it.
